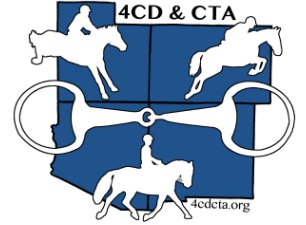

Same horse/rider pairs may not compete in both walk-trot and walk-trot-canter flat classes.

17 and Under Flat WTC classes are split by max height jumped by the rider: either 2' and under, or 2'6" and Over. Riders may not enter both. If entries are low classes may be combined and run at the 2' and Under time.

**Rider Information**

- All riders must be 4CD&CTA members or have paid the non-member insurance fee of \$25.
- **All participants must have a signed release filed with the show office before riding on the show grounds.**
- Non-entered riders are not allowed to ride on the show grounds, unless he/she boards at the facility. This applies to pony rides and letting people "sit" on your horse.
- Junior riders (under 18) must be accompanied by a supervising adult at all times.

**Attire:**

- **A secured ASTM F-1163 approved helmet is required by all riders while mounted.**
- Appropriate footwear (boot with a heel) is mandatory.
- Show attire is admired, not required. Please dress appropriately for the weather (ie: don't wear a show coat when it is 85+)

**Horse Information:**

- A current (within the last 12 months) negative Coggins test will be required and a copy must be mailed with your entry, or the digital version emailed to the secretary.
- Horses must have been vaccinated for Rhino/Flu in the spring. Proof of vaccination can be provided by a copy of your vet's receipt, the USEF form, or if owner vaccinated proof of such (can be a signed affidavit of vaccination.) It can be mailed with entry or scanned and emailed to secretary. Contact secretary in cases of horses who cannot receive vaccine.
- Horse should be free of lameness and/or communicable health issues. Competitors are asked to check their horse's temperature before leaving for the competition. If it is over 101.5 they should stay home. Competitors may be asked to retire and leave the grounds if this is found otherwise.
- Horses not entered in the show are not allowed on the grounds unless boarded at the facility. There are sometimes exceptions to this, based on facility, but will not be available at our 2016 shows.
- A competitor may be asked to retire if, in the opinion of show management, the mount shows signs of exhaustion.

**Refunds**

We give refunds for any reason up to, and including, the day of the show. The more notice you can give the secretary the better though.

**Facility Information:**

Please be courteous to our hosts by:

- Cleaning up after yourself and your horse
- Not bringing dogs onto the show grounds (not even in your car/truck)
- Educating your spectator friends and family about horse safety and show etiquette.

**Our shows are completely volunteer run, so please consider helping us out to keep these shows happening. Contact the show manager if you can help:**

- Set up the dressage arena/jumps the day before the show
- Office help the day of the show

- Arena help during the show
- Take down the dressage arena/jumps at the end of the day
- Transport the dressage arena/jumps before and after the show

There will be Year End Awards for volunteers in 2017, so if you volunteer make sure your hours are logged with the secretary.

**Warm Up Etiquette:**

- Pass other riders left side to left side.
- Call your practice fences so other riders can steer accordingly.
- All jumps in the warm-up area must be taken with the red flag to your right.

**Class specifics:**

- **Hunter Under Saddle and Hunter Over Fences** are judged on the horse.
- **Equitation on the Flat and Equitation Over Fences** are judged on the rider. Judges may ask for additional tests in equitation on the flat classes.
- **Jumper** classes are judged solely on faults (rails and refusals) and possibly touches and closeness to optimum time. Excessive speed and unsafe riding will not be tolerated. What constitutes such is at the discretion of the show management.

**Hunter/Jumper elimination:**

- Three refusals
- Off course
- Jumping course before it is reset
- Bolting from the ring
- Fall of horse or rider

At the show management's discretion, a rider that is eliminated from the competition due to fall or disobedience may be allowed to continue the round, but will no longer be eligible for placing.

**Year End Awards:**

Equitation and Hunter classes count towards Year End Awards. Competitors must compete at two shows. The competitor with the most points in each age group at each height/division will get the award. Points are tabulated based upon the number of entries in the class plus one
