

RELEASE and INDEMNITY AGREEMENT-Home EQUINE ENTERPRISES, LLC

I/we the undersigned (hereinafter called Rider) hereby indemnify and agree by this signing to release and hold harmless EQUINE ENTERPRISES, LLC, Aztec, NM, Jane Misseri, Salvatore Misseri, Radcliff Misseri, Emily Misseri, Rose Misseri, landowners, stable owners, stable manages, trainers, independent contractors, clinicians, employees, and any other individuals related to the ownership or management of the horse facilities (hereinafter called Owner) from liability for any accident or injuries sustained by Rider, Rider's horse, employees, heirs, representatives, dependents, guests, or animals that may occur while on the property of the Owner.

1. Rider, acting in the capacity as horse owner, student, contestant, spectator, employee, independent contractor, or parent of the undersigned, recognizes that all equestrian related activities are extremely dangerous, that accidents involving horses are frequent, that the condition of the land is often hazardous, that the stables may flood, that stallions are dangerous, and that ring footing is rarely perfect. In light of this knowledge, the undersigned undertakes full responsibility for all harm that may occur to themselves, their children, animals, associates, and guests. With full knowledge, the undersigned releases Owner from any and all responsibilities for accidents and injuries to Rider and any individual associated with Rider while on the property of the Owner.
2. Signing this release is testimony that Rider has purchased adequate medical and liability insurance/protection and that the Owner will assume no responsibility and will be held harmless for any injury or death to Rider and/or Rider's horse and/or property. Losses occasioned by the injury or death of Rider, spectator, guest, horse, or other property shall be covered by the Rider and Rider's insurance. Rider's heirs, representatives, dependents, or guests shall hold Owner harmless as the result of any incident that results in injury and/or death to Rider, Rider's horse and any individual associated with Rider while on the property of the Owner.
3. If Rider's child is under 18 years of age and is the riding participant, then the signature of the parent or guardian is required and indicates acceptance of responsibility by said parent or guardian and release of liability of the Owner.
4. Rider further agrees to indemnify Owner against any liability for physical loss or injury, or damage causing death, or making destruction necessary to horse(s) in Owner's care.
5. Rider further agrees to assume full personal and economic responsibility for any damage or harm that may occur to Rider's and/or Owner's person, persons associated with Rider and/or Owner or Owner's property while Rider is on the Owner's property and caused directly or indirectly by Rider or Rider's actions.
6. It is understood and agreed that Owner assumes no responsibility for any personal property of the Rider and that said property is stored on Owner's premises at the sole risk of the Rider.
